To do a Tour Operator business in Tanzania, one needs to go through the below process one after the other,

- 1. Incorporate a company
- 2. Register with Tax authorities (TIN)
- 3. Secure a Tour Operator registration and License
- 4. Secure business license
- 5. Register with the Social security fund and worker's compensation fund
- 6. Get a work & residence permit for foreign directors of the company if any.
- 7. Open a bank account.

The mandatory requirements at the beginning for one to start operations are no. 1 to 4. The other steps can be accomplished while operating.

The estimated time to complete the process is 45 days. Below is the breakdown for each stage:

Note: These timelines are estimates. We will do our utmost to expedite the process, but please be aware that final approvals depend on the respective government authorities.

Required Information:

To register a company in Tanzania, we will need the following information;

- Company Name
- · Proposed/authorized share capital of the Company
- · Business activities of the Company
- Name, residential address, email address, phone number, and passport-size picture of each shareholder
- Name, residential address, email address, phone number, and passport-size picture for each Director
- Proposed share structure of the company (Each shareholder will hold how many shares)
- Copy of National ID and TIN certificates for each Local Director and Shareholder, if any.
- Proposed registered office address of the company.
- Copies of passports of each foreign shareholder and director of the company.

For tax registration applications, we will require:

- One local director or a Power of Attorney to represent the company
- Duly stamped Company Office Lease Agreement (unless using our virtual office services)

Registration and License for Tour Operator, we need the following;

- Proof of having 4WD fleet of Vehicles registered under Company's name
- All tour vehicles must not be more than 5 years old from the first Registration, and should have Comprehensive insurance
- In case of Citizen owned Company(ies) applicant must have at least 1 road worth vehicle which approved to carry business of Tour Operation in the country.
- Vehicles inspection reports
- Business Plan

For Non-citizen owned Company(ies) the following additions shall apply

- Have a fleet of not less than 10 new vehicles of the type approved for tour business by the TTLB
- All tour vehicles must not be more than 5 years old from the date of the first Registration.
- Provide evidence that, the business project has been registered by Tanzania Investment Centre (TIC), and must provide copy of Certificate of Registration and Incentive from T IC.

Important Notice:

• Beneficial Ownership Requirements

In compliance with Tanzanian regulations, all newly registered companies must disclose Beneficial Ownership (BO) information within 30 days of incorporation. Beneficial Ownership disclosure involves identifying individuals who hold significant influence or control over the company, either directly or indirectly, such as through shareholding, voting rights, or other means of control.

To ensure compliance, we will guide you through the BO submission process and assist in gathering the following additional details for each Beneficial Owner:

a. Whether or not Beneficial Owner is a Politically Exposed Person (PEP)

b. Nature of control or influence in the company (e.g., percentage of shares, voting rights, etc.)

Eden Law Chambers will handle the necessary documentation and submissions on your behalf to ensure compliance with BO regulations. Please note that any changes in Beneficial Ownership post-registration must also be reported within 30 days to maintain compliance.

• Work and Residence Permits

If any foreign directors or bank account signatories do not possess a Tanzanian work and residence permit, securing these permits will be mandatory. We can assist with obtaining the necessary permits to ensure full compliance with Tanzanian regulations.

Should you require assistance with obtaining work and residence permits for any foreign directors or signatories, please let us know. We can either send you a separate proposal for these services or amend this proposal to include the necessary items for securing the permits.

N.B Business License

Each business activity, including safari lodges, incurs separate charges when applying for the license. Please refer to the attached Tourism Fee document for detailed costs associated with each license category relevant to your business.
